The Glens forest is situated in area to the north east of Glenties, in the catchment area of Stracashel river which flows into the Owenea, and the Stranagoppoge which flows into the Finn, both of which are important fishing rivers

The main soil type in The Glens are Blanket peat high level

The main towns and villages located in the catchment area of The Glens forest are Glenties to south east, and Fintown lying north.

The management focus for the forest is concerned with timber production, and as this forest is rich in areas of biodiversity the safeguarding of this is of utmost importance.
