### How do we share your personal data?

Any third-party who handles your information is subject to compliance with applicable data protection legislation and protect your information just as we do. We only disclose personal information that is necessary for them to provide the service that they are undertaking on our behalf.

### How long do we keep your personal data for?

The personal data supplied above will be retained until you wish to remove yourself from the stakeholder list, after which it will be retained for 12 months.

### Security of your personal data

Coillte has taken the appropriate technical and organisational security measures to protect your personal data from loss, abuse and unauthorised access. Access to the personal data has only been granted only to the individuals at Coillte that need to process the personal data in accordance with the purposes that have been stated above.

### Data Breaches and how to make a notification

We take appropriate technical and organisational steps to safeguard your personal data and will notify the Data Protection Commission of data breaches where a risk is identified, not later than 72 hours from awareness.

### What are your rights?

Unless any restrictions apply, you have the following rights:

a) Right of confirmation

You have the right to obtain from Coillte the confirmation as to whether or not personal data which concerns you is being processed.

b) Right of access

You have the right to obtain from Coillte information about your personal data processes at any time and a copy of such information.

c) Right to rectification

You have the right to obtain from Coillte the rectification of inaccurate personal data held on

you. d) Right to erasure (Right to be forgotten)

You have the right to request from Coillte the erasure of personal data held on you.

e) Right of restriction of processing

You have the right to request from Coillte restriction of processing of personal data held on you The
